Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.04%) gained 2.54 points and closed at 6,277.63. The blue-chip index DS30 (0.00%), the Shariah-based index DSES (+0.17%), and the large-cap index CDSET (-0.02%) closed at 2,133.32, 1,362.21, and 1,213.99 points, respectively. Most of the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.12% followed by Engineering (+0.11%), Food & Allied (+0.07%), NBFI (+0.06%), Fuel & Power (+0.03%). Bank experienced the highest loss of 0.06%. Block trades contributed 10.8% of the overall market turnover. Deshbandhu Polymer Limited (+1.0%) was the most traded share with a turnover of BDT 349 million.




