# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.14%) lost 8.93 points and closed at 6,384.10. The blue-chip index DS30 (-0.14%), the Shariah-based index DSES (-0.34%), and the large-cap index CDSET (-0.04%) closed at 2,242.72, 1,396.40, and 1,230.76 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 0.44% followed by NBFI (+0.11%), Engineering (+0.00%). Pharmaceutical experienced the highest loss of 0.22% followed by Fuel & Power (-0.16%), Food & Allied (-0.02%). Block trades contributed 0.8% of the overall market turnover. Bashundhara Paper Mills Limited (-6.7%) was the most traded share with a turnover of BDT 1,194 million.


