


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.53%) lost 33.96 points and closed at 6,350.14. The blue-chip index DS30 (-0.51%), the Shariah-based index DSES (-0.73%), and the large-cap index CDSET (-0.69%) closed at 2,231.25, 1,386.17, and 1,222.26 points, respectively. Most of the largecap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.83% followed by Engineering (-SEX 0.42%), Bank (-0.38%), Fuel & Power (-0.21%), NBFI (-0.11%), Food & Allied (-0.08%), and Telecommunication (0.00%), respectively. Block trades contributed 1.0% of the overall market turnover. Genex Infosys Limited (+6.3%) was the most traded share with a turnover of BDT 1,248 million.


