# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.22%) lost 14.11 points and closed at 6,257.73. The blue-chip index DS30 (-0.22%), the Shariah-based index DSES (-0.19%), and the large-cap index CDSET (-0.10%) closed at 2,123.21, 1,359.92, and 1,210.75 points, respectively. Largecap sectors posted mixed performance today. Engineering booked the highest gain of 0.08% followed by NBFI (+0.03%). Food & Allied experienced the highest loss of 0.21% followed by Bank (-0.15%), Fuel & Power (-0.08%), Pharmaceutical (-0.05%). Block trades contributed 3.5% of the overall market turnover. Fu Wang Food Ltd. (-2.4%) was the most traded share with a turnover of BDT 157 million.




