# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.19%) lost 11.92 points and closed at 6,245.81. The blue-chip index DS30 (-0.23%), the Shariah-based index DSES (-0.28%), and the large-cap index CDSET (-0.03%) closed at 2,118.30, 1,356.17, and 1,210.38 points, respectively. Largecap sectors posted mixed performance today. Bank booked the highest gain of 0.08% followed by NBFI (-0.02%). Food & Allied experienced the highest loss of 0.28% followed by Engineering (-0.25%), Pharmaceutical (-0.16%), Fuel & Power (-0.16%). Block trades contributed 4.7% of the overall market turnover. Khan Brothers PP Woven Bag Industries Limited (-0.2%) was the most traded share with a turnover of BDT 188 million.




