

# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.64%) gained 39.52 points and closed at 6,230.51. The bluechip index DS30 (+0.59%), the Shariah-based index DSES (+0.93%), and the large-cap index CDSET (+0.41%) closed at 2,190.21, 1,355.50, and 1,209.62 points, respectively. All the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.94% followed by Food & Allied (+0.37%), Engineering (+0.16%), Fuel & Power Bank (+0.06%), NBFI (+0.03%),(+0.11%),Telecommunication (0.00%), respectively. Block trades contributed 4.0% of the overall market turnover. Genex Infosys Limited (+5.8%) was the most traded share with a turnover of BDT 381 million.




