Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.28%) gained 17.17 points and closed at 6,232.29. The blue-chip index DS30 (+0.58%), the Shariah-based index DSES (+0.73%), and the large-cap index CDSET (+0.53%) closed at 2,202.39, 1,363.99, and 1,216.94 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.89% followed by Fuel & Power (+0.03%), Bank (+0.02%), Engineering (+0.02%). Food & Allied experienced the highest loss of 0.01% followed by NBFI (0.00%), Telecommunication (0.00%). Block trades contributed 4.4% of the overall market turnover. Genex Infosys Limited (+2.3%) was the most traded share with a turnover of BDT 233 million.




