Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.23%) gained 14.52 points and closed at 6,212.46. The bluechip index DS30 (+0.41%), the Shariah-based index DSES (+0.36%), and the large-cap index CDSET (+0.31%) closed at 2,200.68, 1,359.43, and 1,216.37 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.17% followed by Food & Allied (+0.14%), Engineering (+0.02%), NBFI (+0.01%). Bank experienced the highest loss of 0.04% followed by Fuel & Power (-0.01%), Telecommunication (0.00%). Block trades contributed 6.3% of the overall market turnover. Genex Infosys Limited (+0.2%) was the most traded share with a turnover of BDT 222 million.




