Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.07%) gained 4.49 points and closed at 6,223.03. The blue-chip index DS30 (+0.24%), the Shariah-based index DSES (+0.14%), and the large-cap index CDSET (-0.01%) closed at 2,108.32, 1,353.21, and 1,205.62 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.05%, followed by Food & Allied (+0.04%), Telecommunication (+0.00%), NBFI (-0.01%), Fuel & Power (-0.01%), Bank (-0.02%), and Engineering (-0.05%), respectively. Block trades contributed 5.7% of the overall market turnover. Khulna Printing & Packaging Limited (+9.8%) was the most traded share with a turnover of BDT 256 million.




