Market closed in red

Daily Market Update

The market closed in red today. The benchmark index DSEX (-1.03%) lost 51.32 points and closed at 4,946.68. The blue-chip index DS30 (-1.30%), the Shariah-based index DSES (-0.91%), and the large-cap index CDSET (-1.10%) closed at 1,685.25, 1,112.77, and 992.27 points, respectively. All the large-cap sectors posted negative performance today except Engineering (+4.08%). Pharmaceutical experienced the highest loss of 1.05% followed by Food & Allied (-1.02%), Bank (-0.83%), NBFI (-0.75%), Fuel & Power (-0.71%), and Telecommunication (-0.43%), respectively. Block trades contributed 2.0% of the overall market turnover. Walton Hi-Tech Industries Ltd. (+7.5%) was the most traded share with a turnover of BDT 503 million.




