

Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.02%) lost 1.07 points and closed at 6,261.72. The blue-chip index DS30 (+0.11%), the Shariah-based index DSES (-0.02%), and the large-cap index CDSET (-0.01%) closed at 2,137.66, 1,355.82, and 1,209.40 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.10% followed by Engineering (+0.06%), Textile (+0.06%). Food & Allied experienced the highest loss of 0.02% followed by Bank (-0.01%), Fuel & Power (0.00%). Block trades contributed 10.3% of the overall market turnover. Bangladesh Shipping Corporation (+9.0%) was the most traded share with a turnover of BDT 352 million.




