

Market closed in red


The market closed in red today. The benchmark index DSEX (-0.35%) lost 17.49 points and closed at 4,916.97. The blue-chip index DS30 (-0.49%), the Shariah-based index DSES (-0.28%), and the large-cap index CDSET (-0.33%) closed at 1,669.37, 1,108.80 and 981.84 points, respectively. All the large-cap sectors posted negative performance today except Pharmaceutical (+0.14%), and Telecommunication (+0.36%). Engineering experienced the highest loss of 5.10% followed by NBFI (-1.51%), Fuel & Power (-0.53%), Food & Allied (-0.47%), and Bank (-0.45%), respectively. Block trades contributed 3.0% of the overall market turnover. Northern General Insurance Company Ltd. (+9.7%) was the most traded share with a turnover of BDT 225 million.



The Company has informed that the Board of Directors has decided a phase-wise investment of Tk. 227.00 crores for the purpose of increasing manufacturing capacity and setting up operations in Special Economic Zone under Bangladesh Economic Zones Authority (BEZA).
