

Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.10%) lost 6.6 points and closed at 6,494.25. The blue-chip index DS30 (-0.35%), the Shariah-based index DSES (-0.59%), and the large-cap index CDSET (-0.16%) closed at 2,308.06, 1,419.70, and 1,259.43 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 0.16% followed by Food & Allied (+0.00%), Telecommunication (0.00%). Pharmaceutical experienced the highest loss of 0.64% followed by Fuel & Power (-0.37%), Engineering (-0.25%), NBFI (-0.17%). Block trades contributed 0.6% of the overall market turnover. Eastern Housing Limited (+9.4%) was the most traded share with a turnover of BDT 1,240 million.




