


# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.03%) gained 2 points and closed at 6,265.16. The blue-chip index DS30 (-0.11%), the Shariah-based index DSES (+0.13%), and the large-cap index CDSET (+0.01%) closed at 2,136.44, 1,358.75, and 1,211.56 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.25% followed by Engineering (+0.12%), Pharmaceutical (+0.08%), Fuel & Power (+0.01%). Bank experienced the highest loss of 0.01% followed by Telecommunication (0.00%), NBFI (0.00%). Block trades contributed 7.4% of the overall market turnover. Gemini Sea Food Ltd. (+3.6%) was the most traded share with a turnover of BDT 261 million.




