Daily Market Update

The market closed in red today. The benchmark index DSEX (-1.01%) lost 65.45 points and closed at 6,413.02. The blue-chip index DS30 (-0.93%), the Shariah-based index DSES (-0.80%), and the large-cap index CDSET (-0.77%) closed at 2,277.34, 1,406.78, and 1,244.62 points, respectively. All the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 1.00% followed by NBFI (-0.66%), Engineering (-0.34%), Bank (-0.34%), Fuel & Power (-0.28%), Food & Allied (-0.11%), and Telecommunication (-0.04%), respectively. Block trades contributed 0.8% of the overall market turnover. Eastern Housing Limited (-1.6%) was the most traded share with a turnover of BDT 1,070 million.




