


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.16%) lost 10.52 points and closed at 6,390.18. The blue-chip index DS30 (-0.28%), the Shariah-based index DSES (+0.05%), and the large-cap index CDSET (-0.13%) closed at 2,271.01, 1,407.56, and 1,245.09 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.18% followed by NBFI (+0.13%), Engineering (+0.06%), Pharmaceutical (+0.01%). Bank experienced the highest loss of 0.12% followed by Fuel & Power (-0.01%), Telecommunication (0.00%). Block trades contributed 1.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.5%) was the most traded share with a turnover of BDT 788 million.




