Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.03%) gained 1.72 points and closed at 6,277.89. The blue-chip index DS30 (+0.03%), the Shariah-based index DSES (+0.11%), and the large-cap index CDSET (+0.07%) closed at 2,136.23, 1,361.48, and 1,211.00 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.15% followed by Bank (+0.06%), Engineering (+0.02%), Food & Allied (+0.02%). Fuel & Power experienced the highest loss of 0.01% followed by Telecommunication (0.00%), NBFI (0.00%). Block trades contributed 14.0% of the overall market turnover. Tosrifa Industries Limited (+9.8%) was the most traded share with a turnover of BDT 233 million.




