Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.69%) lost 43.97 points and closed at 6,334.03. The blue-chip index DS30 (-0.91%), the Shariah-based index DSES (-0.91%), and the large-cap index CDSET (-0.75%) closed at 2,245.28, 1,389.78, and 1,231.58 points, respectively. All the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.53% followed by Fuel & Power (-0.36%), Engineering (-0.23%), NBFI (-0.14%), Food & Allied (-0.05%), Bank (-0.01%), and Telecommunication (0.00%), respectively. Block trades contributed 0.7% of the overall market turnover. Navana Pharmaceuticals Limited (+78.1%) was the most traded share with a turnover of BDT 651 million.




