# **Daily Market Update**

Market closed in green

The market closed in green today. The benchmark index DSEX (+0.02%) gained 1.51 points and closed at 6,276.73. The blue-chip index DS30 (-0.01%), the Shariah-based index DSES (+0.10%), and the large-cap index CDSET (-0.04%) closed at 2,134.79, 1,363.28, and 1,214.96 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.09% followed by Engineering (+0.03%), Bank (+0.01%). Food & Allied experienced the highest loss of 0.31% followed by Fuel & Power (-0.05%), Telecommunication (0.00%). Block trades contributed 6.8% of the overall market turnover. Emerald Oil Industries Ltd. (+3.2%) was the most traded share with a turnover of BDT 250 million.


