


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.62%) gained 39.65 points and closed at 6,471.00. The bluechip index DS30 (+0.90%), the Shariah-based index DSES (+1.01%), and the large-cap index CDSET (+0.66%) closed at 2,306.46, 1,418.82, and 1,265.28 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.02% followed by Bank (-0.25%), Fuel & Power (-0.25%), Food & Allied (-0.19%), Telecommunication (-0.15%), Engineering (+0.18%), and Pharmaceutical (+1.67%), respectively. Block trades contributed 0.7% of the overall market turnover. Orion Pharma Ltd. (+9.9%) was the most traded share with a turnover of BDT 766 million.


