Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.84%) gained 45.18 points and closed at 5,392.65. The bluechip index DS30 (+0.92%), the Shariah-based index DSES (+1.17%), and the large-cap index CDSET (+0.49%) closed at 2,091.25, 1,165.51, and 1,094.52 points, respectively. All large-cap sectors posted positive performance today. NBFI booked the highest gain of 2.20% followed by Fuel & Power (+1.08%), Engineering (+0.77%), Pharmaceutical (+0.64%), Telecommunication (+0.52%), Food & Allied (+0.28%), and Bank (+0.09%), respectively. Block trades contributed 2.0% of the overall market turnover. Orion Infusion Ltd. (+2.3%) was the most traded share with a turnover of BDT 235 million.




