

The market closed in red today. The benchmark index DSEX (-0.14%) lost 7.16 points and closed at 4,971.61. The blue-chip index DS30 (-0.61%), the Shariah-based index DSES (-0.42%), and the large-cap index CDSET (-0.49%) closed at 1,690.79, 1,121.59, and 995.93 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 5.20% followed by Engineering (+3.39%), Fuel & Power (+0.52%), and Bank (+0.38%). Food & Allied experienced the highest loss of 1.53% followed by Telecommunication (-1.39%) and Pharmaceutical (-0.50%). Block trades contributed 1.6% of the overall market turnover. Sandhani Life Insurance Company Ltd. (+10.0%) was the most traded share with a turnover of BDT 436 million.


