Daily Market Update

Market closed in red today. The benchmark index DSEX (-0.97%) lost 52.61 points and closed at 5,390.70 points today. The blue-chip index DS30 (-0.81%) and the shariah based index DSES (-0.96%) both closed in red. All the large cap sectors showed negative performance today. Telecommunication experienced the highest loss of 2.16% followed by Food & Allied (-1.67%), Engineering (-1.16%), NBFIs (-1.05%), Power (-1.00%), Banks (-0.58%), and Pharmaceuticals (-0.40%). Total turnover stood at BDT 4.0 billion (USD 47.6 million). Bangladesh Steel Re-Rolling Mills Limited (-1.5%) was the most traded share with a turnover of BDT 132.3 million.


