Market closed in red

Market closed in red today. The benchmark index DSEX (- Sector Index 0.26%) lost 13.94 points and closed at 5,395.75 points today. Banks NBFIs The blue-chip index DS30 (-0.21%) and the shariah based Mutual Funds index DSES (-0.23%) both closed in red. All the large cap General Insurance sectors showed negative performance except Power Life Insurance (+1.36%) and Food & Allied (+0.35%) today. Pharmaceuticals Telecommunicat Pharmaceuticals posted the highest loss of 0.62% followed by Banks (-0.61%) Fuel & Power Engineering (-0.56%), Telecommunication (-0.37%) and Cement NBFIs (-0.35%). Total turnover stood at BDT 4.6 billion (USD Services & Real E 55.5 million). Beximco Limited (0.4%) was the most traded Engineering Food & Allied share with a turnover of BDT 274.2 million. IT


