


Daily Market Update

DSEX Index Closing 4,891.53 ↑ (+29.31, +0.60%) Market closed in green

The market closed in green today. The benchmark index sectors DSEX (+0.60%) gained 29.31 points and closed at 4,891.53. The blue-chip index DS30 (+1.08%), the Shariah-based index DSES (+0.53%), and the large-cap index CDSET (+0.85%) closed at 1,714.65, 1,137.34, Gen and 999.70 points, respectively. All the large-cap sectors Life posted positive performance today except NBFI (- Tele 0.31%). Food & Allied booked the highest gain of 2.73% Pha followed by Fuel & Power (+0.54%), Pharmaceutical Fue (+0.47%), Telecommunication (+0.26%), Engineering Cerr (+0.20%), and Bank (+0.05%), respectively. Block trades Serv contributed 23.8% of the overall market turnover. Eng Beximco Pharmaceuticals Ltd. (+6.2%) was the most traded share with a turnover of BDT 1,541 million.
