Daily Market Update


Market closed in green today. The benchmark index DSEX (+0.01%) gained 0.72 points and closed at 4,933.89 points today. The blue chip index DS30 (+0.88%) and the shariah based index DSES (+1.30%) both closed in green. All the large cap sectors showed negative performance today except Engineering (+0.68%) and Power (+0.19%). Food & Allied experienced the highest loss of 1.58% followed by Pharmaceuticals (-0.23%), Telecommunication (-0.19%), Banks (-0.12%) and NBFIs (-0.04%). Turnover stood at BDT 4.1 billion (USD 48.7 million). JMI Syringes & Medical Devices Ltd. (+0.6%) was the most traded share with a turnover of BDT 215.5 million.
