# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+1.65%) gained 82.76 points and closed at 5,094.06. The blue-chip index DS30 (+0.96%), the Shariah-based index DSES (+1.05%), and the large-cap index CDSET (+1.39%) closed at 1,756.89, 1,170.66, and 1,030.34 points, respectively. All the large-cap sectors posted positive performance today. Bank booked the highest gain of 3.97% followed by Fuel & Power (+3.50%), NBFI (+2.79%), Telecommunication (+1.40%), Food & Allied (+1.12%), Engineering (+0.63%), and Pharmaceutical (+0.10%), respectively. Block trades contributed 0.9% of the overall market turnover. Beximco Pharmaceuticals Ltd. (-3.3%) was the most traded share with a turnover of BDT 590 million.


