Daily Market Update


Market closed in green today. The benchmark index DSEX (+0.35%) gained 17.50 points and closed at 4,959.73 points today. The blue chip index DS30 (+0.97%) and the shariah based index DSES (+0.12%) both closed in green. All the large cap sectors showed positive performance today except Power (-0.23%) and Engineering (-0.11%). Food & Allied booked the highest gain of 4.43% followed by Telecommunication (+0.86%), NBFIs (+0.50%), Banks (+0.21%) and Pharmaceuticals (+0.20%). Turnover stood at BDT 3.9 billion (USD 46.8 million). Monno Jute Staffers (+5.2%) was the most traded share with a turnover of BDT 334.6 million.
