


# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.31%) lost 15.78 points and closed at 5,088.87. The blue-chip index DS30 (-0.50%), the Shariah-based index DSES (-0.83%), and the large-cap index CDSET (-0.43%) closed at 1,752.87, 1,153.38, and 1,028.00 points, respectively. All the large-cap sectors posted negative performance today except NBFI (+0.20%), and Fuel & Power (+0.36%). Food & Allied experienced the highest loss of 2.00% followed by Engieering (-1.75%), Telecommunication (-0.91%), Bank (-0.75%), and Pharmaceutical (-0.61%), respectively. Block trades contributed 1.0% of the overall market turnover. Beximco Pharmaceuticals Ltd. (+2.7%) was the most traded share with a turnover of BDT 541 million.
