


Daily Market Update

21 September 2020 DSEX Index Closing 5,012.13 ↓ (-76.74, -1.51%) *Market closed red*

The market closed in red today. The benchmark index s DSEX (-1.51%) lost 76.74 points and closed at 5,021.13 moints. The blue-chip index DS30 (-1.48%), the Shariahbased index DSES (-1.32%), and the large-cap index CDSET (-1.40%) all closed in red. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 1.66% followed by Telecommunication (-1.56%), Banks (-1.54%), NBFIs (- P 1.54%), Engineering (-1.44%), Power (-1.20%), and F Pharmaceuticals (-1.01%). Turnover stood at BDT 9.8 c billion (USD 115.1 million). Block trades contributed 0.9% s of the overall market turnover. Delta Brac Housing (- E 2.1%) was the most traded share with a turnover of BDT F 266.4 million.

The Company has informed that the Board of Directors has approved the sale of its Aframax Tanker Omera Queen at an agreed price of USD 8.08 Million following standard terms & conditions of MOA. MT Omera Queen has been in operation under Bangladesh Flag for more than 9 years and has successfully completed 102 voyages; achieving an outstanding ROI of 18%. Decision was made as due to her aging, the vessel's maintenance cost was increasing and anticipated huge dry dock expenditure The Board of Directors has also provided further consent to the management for procuring similar vessel as replacement within a price range of max USD 22 million and capacity of 100,000 to 115,000 Metric Tons.
