# **Daily Market Update**


Market closed in green today. The benchmark index DSEX (+0.07%) gained 3.96 points and closed at 5,390.85 points today. The blue-chip index DS30 (+0.33%) closed in green while the shariah based index DSES (-0.07%) closed in red. All the large cap sectors showed positive performance today except Food and Allied (-0.07%). Telecommunication posted the highest gain of 0.92% followed by Engineering (+0.88%), Power (+0.60%), Pharmaceuticals (+0.39%), Banks (+0.04%) and NBFIs (+0.03%). Total turnover stood at BDT 5.1 billion (USD 61.8 million). Khulna Power Company Limited (-4.2%) was the most traded share with a turnover of BDT 307.8 million.
