


Weekly Report on Mutual Funds

Chart 1 - Change in weighted average Price to NAV ratio of




today's (February 26, 2023) close prices, the sectoral Price to NAV stood at 0.66x, higher than last week's Price to NAV of 0.65x. On average, price of the mutual funds increased by 0.14% and NAV of mutual funds decreased by 0.56% from previous week against a negative 0.66% WoW change in DSEX. Among all the asset managers, ICB AMCL performed the best in terms of NAV return of its funds, losing -0.02% during the week. Among the 36 mutual funds, 34 of them were trading at discount. Market capitalization of 36 funds stood at BDT 37.5 billion (USD 350.6 million), while the Asset Under Management (AUM) of the sector stood at BDT 57.2 billion (USD 534.5 million). RACE holds the highest market share of 50.1% with 10 funds and AUM of BDT 28.6 billion. The fund manager has the lowest Price/NAV ratio of 0.55x, while LR Global stood at the second lowest Price/NAV ratio of 0.65x. The average daily turnover of the sector stood at BDT 2.1 million in the last trading week, which was 71.5% lower than the previous week's turnover value.

The fund managers have reported NAV of the closed-ended mutual funds for the week ending on February 23, 2023. Based on the recently reported NAV and



Chart 4 - YTD NAV Return of Mutual Funds:


