


# **Weekly Report on Mutual Funds**



Chart 1 - Change in weighted average Price to NAV ratio of the sector in the last two months:





The fund managers have reported NAV of the closed-ended mutual funds for the week ending on January 09, 2020. Based on the recently reported NAV and today's (January 12, 2020) close prices, the sectoral Price to NAV stood at 0.60x, higher than last week's Price to NAV of 0.58x. On average, price of the mutual funds remained flat and NAV of mutual funds decreased by 3.63% from previous week against a negative 5.87% WoW change in DSEX. Among all the asset managers, SEML performed best in terms of NAV return of its funds, losing 2.63% during the week.

Among the 37 mutual funds, 35 of them were trading at discount. Market capitalization of 37 funds stood at BDT 30.7 billion (USD 374.1 million), while the Asset Under Management (AUM) of the sector stood at BDT 51.4 billion (USD 626.9 million). RACE holds the highest market share of 54.0% with 10 funds and AUM of BDT 27.8 billion. The fund manager has the lowest Price/NAV ratio of 0.43x, while Vanguard stood at the second lowest Price/NAV ratio of 0.58x. The average daily turnover of the sector stood at BDT 40.9 million in the last week, which was 6.1% lower than the previous week's turnover value.


