


# **Weekly Report on Mutual Funds**

June 04, 2023


Chart 1 - Change in weighted average Price to NAV ratio of



The fund managers have reported NAV of the closed-ended mutual funds for the week ending on June 01, 2023. Based on the recently reported NAV and today's (June 04, 2023) close prices, the sectoral Price to NAV stood at 0.64x, lower than last week's Price to NAV of 0.65x. On average, price of the mutual funds increased by 0.12% and NAV of mutual funds increased by 1.69% from previous week against a positive 0.47% WoW change in DSEX. Among all the asset managers, RACE performed the best in terms of NAV return of its funds, gaining 3.02% during the week. Among the 36 mutual funds, 33 of them were trading at discount. Market capitalization of 36 funds stood at BDT 37.7 billion (USD 349.3 million), while the Asset Under Management (AUM) of the sector stood at BDT 58.8 billion (USD 545.3 million). RACE holds the highest market share of 50.9% with 10 funds and AUM of BDT 30 billion. The fund manager has the lowest Price/NAV ratio of 0.53x, while LR Global stood at the second lowest Price/NAV ratio of 0.64x. The average daily turnover of the sector stood at BDT 121.5 million in the last trading week, which was 391.0% higher than the previous week's turnover value.



### Chart 4 - YTD NAV Return of Mutual Funds:




