



Weekly Report on Mutual Funds October 15, 2023






The fund managers have reported NAV of the closed-ended mutual funds for the week ending on October 12, 2023. Based on the recently reported NAV and today's (October 15, 2023) close prices, the sectoral Price to NAV stood at 0.65x, similar to last week's Price to NAV of 0.65x. On average, price of the mutual funds increased by 0.03% and NAV of mutual funds decreased by 0.21% from previous week against a positive 0.12% WoW change in DSEX. Among all the asset managers, Vanguard performed the best in terms of NAV return of its funds, gaining 0.14% during the week. Among the 36 mutual funds, 34 of them were trading at discount. Market capitalization of 36 funds stood at BDT 37.3 billion (USD 337.9 million), while the Asset Under Management (AUM) of the sector stood at BDT 57.1 billion (USD 516.5 million). RACE holds the highest market share of 50.7% with 10 funds and AUM of BDT 28.9 billion. The fund manager has the lowest Price/NAV ratio of 0.55x, while LR Global stood at the second lowest Price/NAV ratio of 0.66x. The average daily turnover of the sector stood at BDT 1.3 million in the last trading week, which was 60.1% lower than the previous week's turnover value.

Chart 3 - Price/NAV of the fund manager:



Chart 4 - YTD NAV Return of Mutual Funds:


