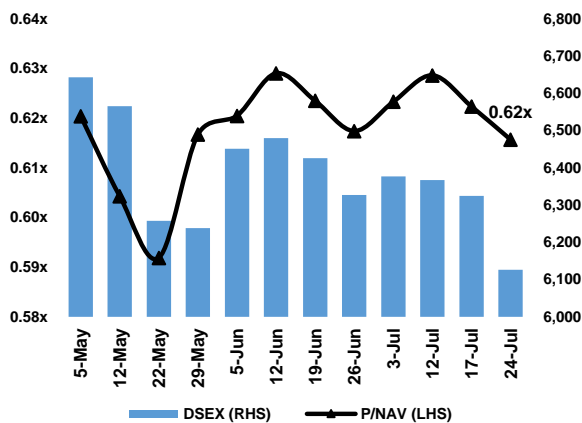


Weekly Report on Mutual Funds July 24, 2022

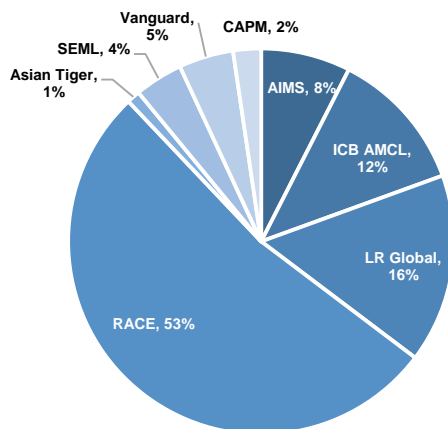
Chart 1 - Change in weighted average Price to NAV ratio of

The fund managers have reported NAV of the closed-ended mutual funds for the week ending on July 21, 2022. Based on the recently reported NAV and today's (July 24, 2022) close prices, the sectoral Price to NAV stood at 0.62x, similar to last week's Price to NAV of 0.62x. On average, price of the mutual funds decreased by 2.50% and NAV of mutual funds decreased by 1.45% from previous week against a negative 3.13% WoW change in DSEX. Among all the asset managers, SEML performed the best in terms of NAV return of its funds, losing -0.80% during the week. Among the 35 mutual funds, 33 of them were trading at discount. Market capitalization of 35 funds stood at BDT 36.9 billion (USD 391 million), while the Asset Under Management (AUM) of the sector stood at BDT 60 billion (USD 635.1 million). RACE holds the highest market share of 52.6% with 10 funds and AUM of BDT 31.6 billion. The fund manager has the lowest Price/NAV ratio of 0.51x, while LR Global stood at the second lowest Price/NAV ratio of 0.63x. The average daily turnover of the sector stood at BDT 40 million in the last trading week, which was 18.7% higher than the previous week's turnover value.

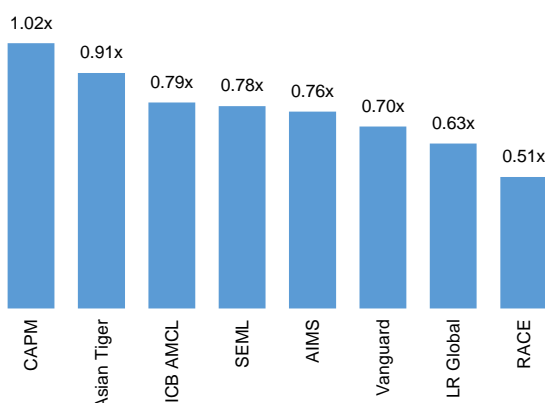

Chart 4 - YTD NAV Return of Mutual Funds:

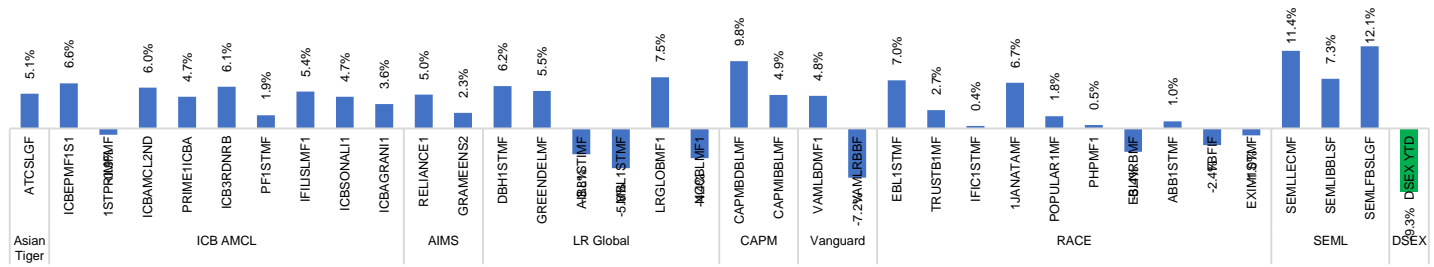
