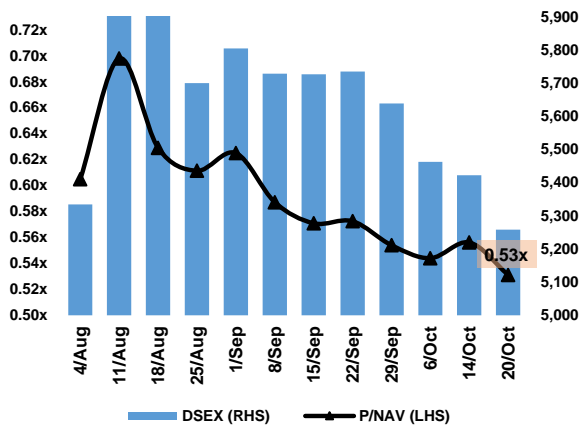


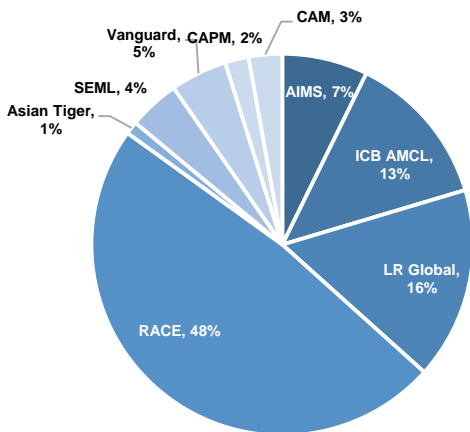

Chart 1 - Change in weighted average Price to NAV ratio of



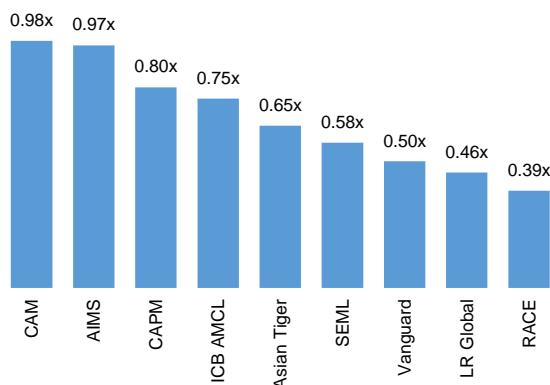

The fund managers have reported NAV of the closed-ended mutual funds for the week ending on October 17, 2024. Based on the recently reported NAV and today's (October 20, 2024) close prices, the sectoral Price to NAV stood at 0.53x, lower than last week's Price to NAV of 0.56x. On average, price of the mutual funds decreased by 5.82% and NAV of mutual funds decreased by 1.41% from previous week against a negative 3.03% WoW change in DSEX. Among all the asset managers, ICB AMCL performed the best in terms of NAV return of its funds, gaining 0.33% during the week. Among the 37 mutual funds, 35 of them were trading at discount. Market capitalization of 37 funds stood at BDT 26.3 billion (USD 219 million), while the Asset Under Management (AUM) of the sector stood at BDT 49.5 billion (USD 412.2 million). RACE holds the highest market share of 48.3% with 10 funds and AUM of BDT 23.9 billion. The fund manager has the lowest Price/NAV ratio of 0.39x, while LR Global stood at the second lowest Price/NAV ratio of 0.46x. The average daily turnover of the sector stood at BDT 69 million in the last trading week, which was 54.3% higher than the previous week's turnover value.

Chart 4 - YTD NAV Return of Mutual Funds:

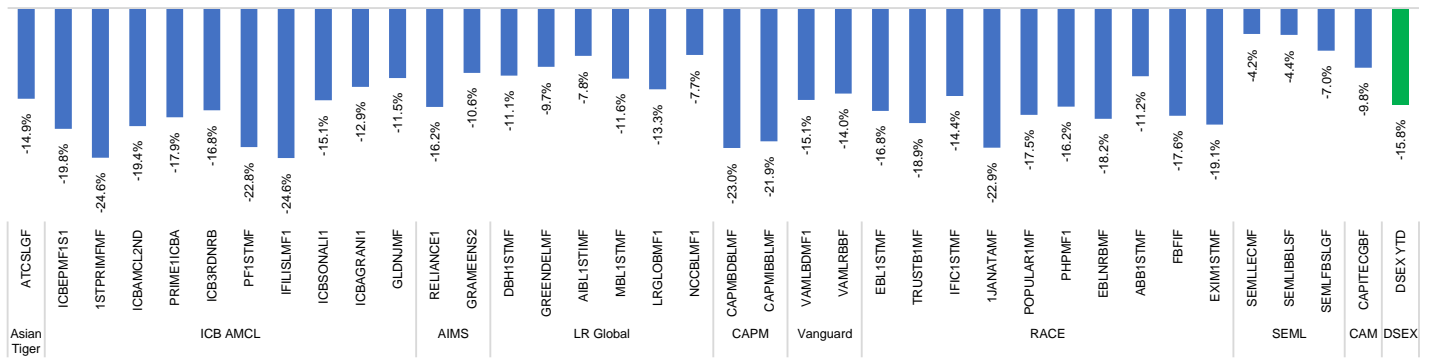
